THE GOALS OF THE RESTORE ARE (1) TO RAISE MONEY FOR HABITAT'S OTHER PROGRAMS, (2) TO DIVERT USABLE MATERIALS FROM LANDFILLS, AND (3) TO MAKE USABLE MATERIALS AVAILABLE TO THE PUBLIC AT A REASONABLE PRICE.
